

The chemical structure of Xylitol is a five-carbon polyol. It is shown in a Fischer projection with a central vertical chain of five carbon atoms. The top and bottom carbons are bonded to a hydroxymethyl group (CH₂OH). The second carbon from the top is bonded to a hydrogen atom (H) on the left and a hydroxyl group (OH) on the right. The third carbon from the top is bonded to a hydroxyl group (OH) on the left and a hydrogen atom (H) on the right. The fourth carbon from the top is bonded to a hydrogen atom (H) on the left and a hydroxyl group (OH) on the right. The bottom carbon is bonded to a hydroxymethyl group (CH₂OH).
